

Council Members Present: Pastor Nancy Jaster, Lydia Strakos, Cheryl Caraway, Karen Caraway, Dottie Caldwell, Lindsey Smith

Prayer Concerns: Dorothy Caraway

Approval of Agenda: Lindsey moved to approve, Pastor seconded, motion passed to approve the agenda.

Approval of Minutes from previous meeting: Karen moved to approve, Dottie seconded, motion passed to approve November minutes.

Reports:

Treasurer: Still within the budget; November was a good month for contributions; but still behind for the whole year.

Pastor: Submitted as information.

Proclaim: Nothing to report.

Nurture: Dottie reported that the Sunday School kids will have angel and shepherd costumes for when they sing in church on December 22, 2024

Response: Enchiladas left over from the Ministerial Alliance Supper will be used for Wednesday night Advent supper.

Food will be taken over to Dorothy Caraway.

Property: Roof is complete. Locks have been worked on; still have to jiggle the key a bit to get them to open the door.

Old Business:

- Lydia has talked to Joel Anderson and Mike Rothman about being on council again. We still need to speak with Bobby Hahn, Steve Bales and Larena Hahn about being council members.
- We have volunteers that will be taking care of all of our building cleaning responsibilities.
- Start working on the committee's annual reports.
- Pastor and Terri have volunteered not to take an annual raise for year 2025 but requested to raise their retirement to 12% for each of them, which has been agreed upon.

New Business:

- It was discussed at the Budget Workshop to open CDs from various accounts to enhance interest earning.
 Karen moved and Dottie seconded to approve Pastor opening 2 CDs from the Mission Investment Fund.
 1-\$25,000 and 1-\$20,000; motion passed.
- Discussion on opening two 6-month CDs from the FNB Living Memorial Savings Account and the FNB Fund Account. Lindsey moved and Dottie seconded to authorize Karen Caraway to open a \$15,000 6-month CD from the FNB Living Memorial Savings Account and a \$7,000 6- month CD from the FNB Dedicated Funds Account; motion passed.
- Discussion on having a council meeting in February since we have the annual meeting in January. The decision was to schedule it and play it by ear.
- Our Windstorm Insurance is up for renewal on January 6, 2025. Our current agent is out of business. Pastor has talked to Rob Barjenbruch with Texas Farm Bureau in Victoria. We have to wait one month to rewrite and renew our policy.
- Annual meeting is January 26, 2025 right after church, in the church. Will have potluck brunch afterward.


